73. Correct answer (b). Mahbub Shah vs Emperor: (1945) 47 BOMLR 941: It was held that Care must be taken not to confuse same or similar intention with common intention. The partition which divides "their bounds" is often very thin; nevertheless, the distinction is real and substantial, and if overlooked, will result in miscarriage of justice. The inference of common intention should never be reached unless it is a necessary inference deducible from the circumstances of the case.

75. Correct answer (c). Wilful conduct. Section 86 of BNS states "cruelty" means any wilful conduct which is of such a nature as is likely to drive the woman to commit suicide or to cause grave injury or danger to life, limb or health (whether mental or physical) of the woman.
76. Correct answer (b). Section 2(3) defines "child". It states that child means any person below the age of eighteen years.
77. Correct answer (b). False. In India, the offense of rape is not gender-neutral. Under BNS, rape is defined as an act committed by a man against a woman. The law specifically mentions that the perpetrator is a man, and the victim is a woman.
78. Correct answer (d). As per Section 4, six kinds of punishments are available under the BNS 2023
- i. Death;
 - ii. Imprisonment for life;
 - iii. Imprisonment, which is of two descriptions, namely:—
 - Rigorous, that is, with hard labour;
